BD Experience would like to share with you important information regarding VISITAX.

The Ministry of Finance and Planning of the State Government through the Quintana Roo Tax Administration System (SATQ) announced that, as of 1st. April, 2021, in the State of Quintana Roo, the "right of tourist use" will be applied. This will be an amount of \$ 224.00 Mexican pesos charged to foreign tourists.

A website will be made available for tourists in which, by filling in a simple form, the tourist will be able to pay the tax and obtain proof of their payment.

Our mutual passengers will be able to make the payment on the digital platform before their arrival, when entering the destination or during their stay, since the verification of the payment will be made when the tourist leaves the State.

The requirements that are requested to complete the VISITAX form are the following:

- Number of people traveling.
- Name, age and passport number of each individual.
- Departure date.
- Data to make the payment electronically.

When the tourist has concluded their stay in the State:

- They must show their proof of payment at the airport check point prior to boarding. If they do not have the payment proof, they will receive assistance to do it at that time.
- Payment for families or groups can be made in a single payment, as long as the data requested by the system for each member is completed and individualized receipts are obtained.
- Visitors who cross the border of Belize by land will have a 100% subsidy.

VISITAX comes into force to facilitate the payment of tourist usage fee

- *The new payment will take effect on April 1, 2021*
- *Tourists can pay before or during their stay in Quintana Roo*

Cancun, Quintana Roo. March 19, 2021 - As a result of the State Congress' decision to create a new payment for foreign tourists who leave the state as of April 1, 2021, the Secretary of Finance and Planning of the state government through the Quintana Roo Tax Administration System (SATQ) presented the VISITAX system to facilitate its payment.

The usage fee consists of payment by foreign tourists of approximately USD 10, depending on the exchange rate. Tourists can pay prior to their arrival, when entering, or during their stay since the payment verification will happen once tourists leave the state.

A website will be available to users in which, by filling in a simple form, tourists will be able to make the payment of said contribution and obtain a receipt.

The following information is requested to fill out the VISITAX form:

- Number of people traveling
- Name, age, and passport number - individually
- Departure date
- Data to make the payment electronically

When tourists have concluded their stay in Quintana Roo, they must show their receipt at the airport filter prior to boarding. In case of not having it, they will get assistance to do it at that time.

Payment for families or groups can be made in a single exhibition, as long as the data required by the system for each individual is completed and thus, individualized receipts will be provided. Visitors crossing the border with Belize by land will get a 100% subsidy.
